Activation: (REQUIRED) Turning on the water, programming the controller, cycling through each zone, checking & adjusting sprinkler heads. **DOES NOT INCLUDE REPAIRS NEEDED TO THE SYSTEM.** If repairs are needed at time of activation, they will be billed on a quarter hour basis for labor plus any parts used.

Winterization: (REQUIRED) Purge the water in the lines to prevent freezing. **DOES NOT INCLUDE REPAIRS NEEDED TO THE SYSTEM.** If repairs are needed at time of winterization, your repair will be rescheduled prior to the activation of your system the following year.
